A Student Short Video Competition on Privacy and Data Protection

Are you passionate about privacy and data protection? Do you wish to receive <u>the Westin Scholar Award 2023</u> for VUB? We're excited to announce the student video competition on privacy and data protection, where you can showcase your creativity by submitting a short video by May 31st, with an opportunity to get a free pass for <u>the IAPP Europe Data Protection Congress 2023!</u>

Competition rules

1. Eligibility

The competition is open to all students who are enrolled or have followed one of the courses in the-Law & Technology afstudeerrichting-program of the Faculty of Law & Criminology at VUB.

2. Content and format

- Participants must submit a short video no longer than 2 minutes in length. It can be
 a vlog telling a personal experience, a video for raising public awareness, an
 interview with a relevant person, or other, as relevant.
- The submitted video should be related to one of the following topics:

- Why are you interested in privacy and data protection law?
- What is the next major privacy or data protection challenge in your view?
- Why would you recommend students to study privacy and data protection?
- The submission should be in a commonly used video format (eg., mp4, mov, wmv, flv) and of a reasonable file size (up to 1GB).
- The language used in the video should be English.

3. Submission

- The submission deadline is **Wednesday 31 May 2023 (23:59 CEST)**.
- All submissions should be sent to Wenkai.Li@vub.be. A link via Google Drive,
 OneDrive or Dropbox is acceptable.
- The following information should be provided when submitting the video:
 - A title and a brief description (no more than 100 words) or 3 keywords for the video;
 - Name of the creator(s) of the video;
 - Name of the course followed.

4. Evaluation criteria

Videos will be judged based on the following criteria:

- Relevance (30%): Alignment with the subject of the call.
- Clarity of the message (40%): This criterion evaluates the video's message and how
 well it is conveyed. The content should be relevant to the required topics, accurate,
 informative, well-organized, and effective in communicating the intended
 message.
- Creativity and originality (30%): This criterion evaluates the video's creative elements, including its originality, uniqueness, and engaging storytelling.

5. Judging panel

The winning video will be selected by a panel of judges consisting of the following members:

6. Award

The winner of the competition will be awarded the Westin Scholar Award for VUB, provided by the International Association of Privacy Professionals (IAPP). The winner will receive a free pass to attend the IAPP Europe Data Protection Congress 2023, to be held on 15-16 November 2023 in Brussels (the registration is scheduled between 12 June and 14 July). The winner will be notified before the deadline for registration.
